Key Responsibilities:

- Understand and support regulatory processes for drilling and completion works
- Implement RFP process for completion & workover services including generating RFP document, evaluating bid proposals and contracting.
- Develop, implement and maintain completion & workover programs to ensure job quality, safety, and cost;
- Develop, implement and maintain well abandonment work programs to ensure job quality, safety, and cost;
- Generate project AFEs and cost control

- Liaise with the project team to design, plan and execute utility wells for water sources, water disposal, salt caverns and observation wells;
- Work closely with the Drilling/Completions Superintendent and the rest of the project team to plan and execute successful projects;
- Provide schedule and cost estimates for drilling and well completions and tracking for on-going work against schedule and budget;
- Ensure department activities are in compliance with Harvest policies and government regulations;

- Coordinate with pad facility group for requirements and schedules;
- Act as a technical resource and provide support and direction, where required, to field operations and other disciplines within the thermal team;
- Liaise with project team for conversions, non-routine workovers and recompletions;
- Provide support coverage for other thermal completion and production engineers during cross-training and vacation leaves

- Minimum 5 years' related Completion, workover and well abandonment experience
- Field experience would be an asset
