Harvest has an immediate opening for a **Contract Operator**, reporting to the Lead Operator. This is a contract position based out of Crossfield field.

Key Responsibilities:

- Ensure field operations follow Harvest health, safety, and environmental policies, procedures, and processes;
- Ensures time communication of environmental or safety incidents according to HS&E protocols;
- Complete monthly EH&S requirements in line with key performance indicators (tank inspections, fire extinguishers etc.);
- Perform Day-to-Day production related activities for respective area and associated properties;
- Participate in frequent well reviews as required;
- Coordinate Day-to-Day operation and upkeep of facilities, roads, pipelines;
- Report daily production problems, environmental or safety incidents;
- Monitor wells and modify daily route based on downtime, production and risk factors;
- Follow overtime management process and gain approval for extended shift overtime prior to execution of work;
- Knowledge share with Foreman, Lead Operator, or other Field Operators based on best practices identified in field;
- Identify methods to reduce OPEX costs where available and communicate to Field Supervisory personnel;
- Participate in operating cost reduction initiatives, assist with actions, and provide status updates as necessary;
- Effectively complete shift handover and provide necessary information to relief Operator to ensure transition of Operations;
- Follow appropriate internal processes regarding management of work schedule;
- Execute field maintenance according to in-source maintenance guidelines and Field Operator skill requirements;
- Ensure accurate and timely reporting of and planning for facility downtime;
- Capture and input key field data into production reporting system according to operational requirements;
- Ensure field reporting related to wells is accurate and timely;
- Ensure field reporting related to facilities is accurate and timely;
- Ensure proper handoff to Well Services for down hole repairs;
- Ensure proper handoff from Well Services to put well back on production post-workover;
- Assist in commissioning and start-up of wells, facilities;
- Understand management of change process and initiate when appropriate;
- Resolve issues or provide information when necessary to landowners, residents, or regulators as directed by Foreman

Qualifications:

• Minimum High School Diploma required; Technical diploma or journeyman certificate in a related discipline would be an asset;



- Valid Class 5 driver's license with a clean driving record;
- Any operating experience with dehydration equipment, compression, high pressure wells, plungers and artificial lift systems, and a good understanding of process facilities would be an asset;
