Harvest has an immediate opening for a **Field Operator** reporting to the Foreman. This is a contract, **part time 2 day/week** position in the Willesden Green area, located near Rocky Mountain House, AB. Production is predominantly gas with some light oil production.

Key Responsibilities:

- Ensure field operations follow health, safety and environmental policies and procedures; participate in safety and environmental inspections at facility.
- Perform day-to-day production related activities for facility; identify optimization techniques to increase production and/or reduce downtime; coordinate day-to-day operation and upkeep of facility.
- This part time position involves a 2 day week which can be discussed at the interview, 9 hours a day work schedule
- Ensure accurate and timely capture of facility costs; participate in operating cost reduction initiatives.
- Assist with inventory management for area; source equipment for performing maintenance tasks in accordance with procurement procedures.
- Identify facility maintenance needs with the Senior Operator; assist in the development of preventative maintenance plans, procedures and schedules; coordinate and provide input on facility upgrades.
- Input key field data into production reporting system in line with operational requirements.
- Maintain chemical pumps, house keeping, pigging and other tasks.

Qualifications:

- Valid Class 5 driver's license.
- Minimum of 2 year of operating experience with pump jacks, pressure vessels, injection pumps, compressors, dehy's and a good understanding of process would be an asset. Equivalent service crew experience could be accepted in some cases.

- Working knowledge of MS Office; knowledge of SCADA based control systems and PVR would be asset.
