This position is classified as a Safety-Sensitive Position. You will be working a 7 on 7 off shift, alternating between days and nights. The successful candidate will reside in a camp facility on a rotational basis. Fly in Fly out from Calgary and Edmonton is available.

### Key Responsibilities:

- Adhering to and enforcing safety policies and procedures.
- Responsible for the efficient operation of the plant process equipment.
- Monitor and control plant conditions and maintain proper documentation including safety and environment reports, operator logs, and maintenance records.
- Understand and perform safety, environmental and regulatory such as hazard identification, equipment lock out, emergency response, and implement safe working procedures.
- Actively control and manage processes in the facility during plant upsets.
- Supporting/responding to unit operations and equipment requirements, including Shift Turnover, Start of Shift orientation, Troubleshooting, and defined rounds.
- Ensure effective communication with the operations team members as well as maintenance, and supervisory staff.
- Participating in and maintaining all required safety certification and training.

### Qualifications:

- **2<sup>nd</sup> class Power Engineering Certificate is preferred.**
- Minimum of 3 years of thermal operating experience with a combination of plant/field experience,
- A strong understanding of plant processes used in SAGD facilities.
- Must possess a valid Class 5 License.
- Able to interpret facility drawings, including shutdown keys, PID's and schematics. Experience with Distributed Control System (DCS) is an asset.
- Familiarity with writing Safe work Permits and the use of field-level Hazard Assessments.
- A solid understanding of processes and equipment used in the SAGD process including water-tube boilers, high pH mechanical vapour compressor evaporators, produced emulsion processing, diluent recovery, tank vapor recovery compression, tank inventory management, and produced water de-oiling.
- High awareness and understanding of potential process safety incidents.
- Self-motivated with a strong work ethic, good communication skills, and a positive attitude.
- Proficient with Microsoft Office programs (Excel, Outlook, and Word), software applications, and facility control systems.
